Parents/Guardians shall pay childcare fees based on the rates specified below. Childcare fees will not be adjusted for late arrival, early pickup, or missed days.

**1. Full-Time Childcare Fees:**

Childcare fee for Full-Time prescheduled childcare is \$165.00 per week.

**2. Part-Time Childcare Fees:** (Enrolled as Part-Time before June 1, 2020)

Childcare fee for Part-Time prescheduled childcare is \$110.00 per week.

Part-Time childcare is 3 days or less per week. Additional days will be charged the full-time rate. After two consecutive weeks, your account will be updated to full-time status.

**3. Full-Time Afterschool Childcare Fees:**

Childcare fee for Full-Time Afterschool prescheduled childcare is \$90 per week.

**4. Part-Time Afterschool Childcare Fees:** (Enrolled as Part-Time before June 1, 2020)

Childcare fee for Part-Time Afterschool prescheduled childcare is \$54 per week. Part-Time Afterschool childcare is 3 days or less after school per week. Additional days will be charged the full-time rate. After two consecutive weeks, your account will be updated to full-time status.

## Timing and Method of Payment

Parents/Guardians shall pay childcare fees on or before the Monday of each week. In addition, if fees are not paid in full and on time, parents/guardians agree to pay \$25.00 late fee. If fees are not paid within 10 days, the child(ren) will not be allowed to attend the facility until payment is received in full. Parents/Guardians agree to pay a \$25.00 fee for all checks returned unpaid. After the second check is returned unpaid, all future payments shall be made in cash.

Payments may be made by cash, check, credit/debit card, automatic draft, or online payments. All tuition paid is nonrefundable. \*If your child is withdrawn from our program while a balance remains on their account, he/she cannot return until the balance has been paid in full.

## Registration Fee

Parents/Guardians shall pay \$75.00 per child as an annual registration fee when this contract is signed. The registration fee is nonrefundable and is not applied to any childcare fees.

## Late Pick-Up Fees

Parents/Guardians agree to pay \$1.00 for each minute after closing until 6:30 P.M. or until pickup. This overtime fee shall be paid with the next scheduled payment.

## Termination of Childcare

Childcare may be terminated by the parent/guardian only by providing the childcare with two weeks advance written notice.

Wildwood Childcare Center retains the right to terminate this contract without notice for the following reasons:

- The child(ren)'s behavior is destructive, uncontrollable, violent, or threatening to the other children or providers at the care facility. This determination is made in the sole discretion of the provider.
- A parent's/guardian's behavior is threatening or abusive to the other children or providers at the care facility.
- Childcare fees are two weeks or more delinquent.

All terminations of this type can be made effective immediately.

## **Modification of Terms**

Wildwood Childcare Center shall be entitled to change any of the terms in this contract, including but not limited to fees, by providing the parents/guardians with 30 days advance written notice of such changes.

## **Afterschool Break Fees**

At any point during the year that schools take a week (or more) long break, the parents are required to pay the full fee for their child(ren). This includes, but not limited to, Spring Break, Thanksgiving Break, Christmas Break, and Summer Break. Parents of children who are considered full-time will pay \$165 per week during the break. Parents of children who are considered part-time will pay \$110 per week during the break. When school resumes the normal payments will resume as well.
